"Article" means a manufactured item: (i) which is formed to a specific shape or design during manufacture; (ii) which has end use function(s) dependent in whole or in part upon its shape or design during end use; and (iii) which does not release, or otherwise result in exposure to, a hazardous chemical under normal conditions of use.




Conqueror complies with the definition of "article" and therefore do not need a Safety Data Sheet.

REACH

REACH is a European regulation which entered into force in June 2007. The regulation covers registration, evaluation, authorisation and restriction processes for chemical substances to ensure the consistency of regulations across the EU. These REACH processes are designed to provide additional information on chemicals, to ensure their safe use and to ensure competitiveness.

None of the substances on the ECHA-SVHC list are used in the manufacture of **Conqueror**. **Antalis** is therefore confident that the papers supplied to its customers comply with the 59 (10) REACH regulations in force and do not require registration procedures.

With the entry into force, last 8th April 2022, of the FSC International statement with which the body took a stand regarding the Russia-Ukraine conflict, all trading certificates in Russia and Belarus have been suspended and all controlled wood sourcing by the two countries has been blocked.

This means that all certificates in Russia and Belarus that allow the sale or promotion of FSC products have been suspended. In addition, all sourcing of controlled forest products from the two countries have been blocked. Therefore, wood and other forest products can no longer be sourced as FSC-certified or controlled from Russia and Belarus for their inclusion in FSC products anywhere in the world.

The consequences of FSC's position for [REDACTED] are the following:

- As per raw materials, we can assure that in 2022 we did not buy and won't buy anything coming directly from Russia and Belarus;
- Regarding eventual raw material already bought and shipped and/or received from those countries, referring to FSC FAQ (chapter 1.6), it is stated that certified or controlled material purchased from Russia and Belarus before 8th April 2022 still maintain its status beyond that date (FSC certification) and can be used for the production of FSC paper;
- Regarding the sale of paper products where Russian or Belarusian raw materials were used before the conflict, there are no bans for selling them with FSC certification.

Moreover, with reference to the FSC decision published on 4th April 2022, regarding the suspension of certificates of materials from Ukraine starting from 4th May 2022 (<https://fsc.org/en/newsfeed/certificates-in-ukraine-conflict-areas-suspended>), we can declare that nothing changes on the FSC certification of [REDACTED] products as we do not have any supplies from Ukraine.

The cotton used in our graphic papers (cotton linter cellulose) consists of fibers that remain attached to the cotton seed after ginning. These fibers are too short to be used for producing textiles. The short fuzz adhering more closely to the seeds is called "linter" and serves as a source of very pure cellulose. The processing to produce cotton linters occurs at the level of the cotton seed during cleaning before pressing. The waste from this cleaning (1st and 2nd cut) is the raw linter that we use in our papers. Cotton linter is a byproduct of virgin cotton production for the textile industry. It is not considered a recycled product by the textile industry because it actually represents the last usable part of the plant from harvesting.

[REDACTED] we are committed to maintaining the highest ethical standards and ensuring that our supply chain is free from any materials that may be associated with forced labor or other unethical practices.

We are monitoring closely our suppliers and their sourcing country of origin.

Are free of dyers that intentionally contain components by azoic nature, Cadmium (Cd), Quicksilver (Hg), Chromium trivalent (Cr⁺³), Chromium hexavalent (Cr⁺⁶), Nickel (Ni) and Aluminium (Al) in compliance with the limits made clear by the Regulation (EC) of the European Parliament and of the Council of 18 December 2006 nr. 1907 (REACH).
4. Are in conformity with:
 - European Standard EN 71-3:2013 and consecutive amendments that specifies requirements and test methods for the migration of 19 elements from toy materials and from parts of toy and specifically toxic elements, some fragrances or flavoring and the use of carcinogenic, mutagen and toxic substances for reproduction (CMR).
 - European Standard EN 71-3:2021 that specifies requirements and test methods for the migration of aluminum, antimony, arsenic, barium, boron, cadmium, chromium (III), chromium (VI), cobalt, copper, lead, manganese, mercury, nickel, selenium, strontium, tin, organic tin and zinc from toy materials and from parts of toys, and in conformity with Directive (UE) 2019/1922.
 - European Standard EN 71-1:2014+A1:2018 that specifies mechanical and physical properties of toy materials and of parts of toys.
 - European Standard EN 71-2:2020 that specifies the flammability properties of toy materials and of parts of toys.
5. Are in conformity with the Italian Legislative Degree no. 206 on 2005, September 6th regarding the common product's safety (see article nr. 102 of this law).
6. Respect limits defined by European Resolution no. 2002/96/CE, modified by Directive 2018/849/EU of the European and of the Council of 30/05/2018, for the following heavy metals: Cadmium, Quicksilver, Chromium hexavalent and Lead.
7. Respect limits defined by Regulation (EU) 2019/1021 of the European Parliament and of the Council of 20/06/19 on Persistent Organic Pollutants (POPs).
8. Don't provide components or constituents with intentional presence of Phthalates and Phenols.
9. The absence of intentional presence of Chlorophenols, however, always in compliance with the legal limits.

10. Comply with thresholds for Formaldehyde established by the Italian and European legislation.
11. Are free from natural rubber latex, given that, where relevant to the product, are manufactured only by synthetic latex.
12. Don't provide components or constituents with intentional presence of Arsenic combinations.
13. Don't include the presence of Polybrominated Biphenyls (PBBs) and Polybrominated Diphenyl Ether (PBDE), stressing however that these substances are used for killing flame in electronic components, not in paper. Therefore, it is reasonable confirm that our products are free of PBB and PBDE and respect the requirements identified in the EU Delegated Directive no. 2018/738 (called ROHS III) amending the ROHS II Directive.
This conformity is extended to the intentional absence of Decabromodiphenyl ether (Deca BDE), a substance included by the court on a list of competence of the previous Resolution from 30.06.2008.

All papers produced by the Society are unqualified for food contact, **except for some papers produced at [REDACTED] Mill** (certified UNI EN 15593:2008), as they do not meet the requirements established by European Regulation no. 1935/2004/CE and subsequent amendments, European Regulation no. 2023/2006/CE and the standard UNI EN 15593:2008.
19. Are devoid of intentional presence of pigments or fillers, ore or extracted pure minerals, included into "Conflict Minerals" database, as issued in the declaration of EICC/GeSI, and in the matter in question:
 - Cassiterite for Tin
 - Columbite-Tantalite or Coltan by the colloquial African

- c. For the paper article is not intended, at any stage of its production, the use of solvents or preservatives, in particular Dimethyl Fumarate (DMF), or primary aromatic amine.
- d. All [REDACTED] paper families are recyclable as defined in art. 3/paragraph 7 of the European Directive n. 94/62/CE on packaging and packaging waste and recoverable in compliance with the harmonized technical standard UNI EN 13430: 2005 (Packaging - Requirements for recoverable packaging).
- e. Furthermore, all [REDACTED] paper families are biodegradable and compostable according to the EN 13432: 2002 standard (Requirements for packaging recoverable by composting and biodegradation) except the coated papers on which compostability we continue to study/investigate and work.

- authorized according to the Directive 2010/75/EU of the European Parliament and of the Council of 24/11/10 on Industrial Emissions (Integrated Pollution Prevention and Control - IPPC), recovered in Italy by Legislative Decree nr. 152/06 and subsequent amendments (Law for the Environment) and by national statute DLGS 46/2014.
